The Baton Rouge Area Foundation provides three services to improve South Louisiana:

1

The Foundation **manages charitable accounts for people and organizations**. Our most popular accounts for individuals are Donor Advised Funds, which are like investment accounts for doing good works. People open and put money in DAFs; we manage the funds and make grants to nonprofits on behalf of donors. The Foundation has granted more than \$530 million since inception in 1964.

Our donors want the greatest returns for the community, so the Foundation's Strategic Consulting Services division **helps nonprofits with strategy and fundraising to produce better outcomes**.

The Foundation **leads civic projects with annual support from our members**. Current projects include coordinating autism services, implementing the University/City Park Lakes master plan that was paid for by our donors, justice reform to reduce the prison population, better public schools and rebuilding city neighborhoods with partners.

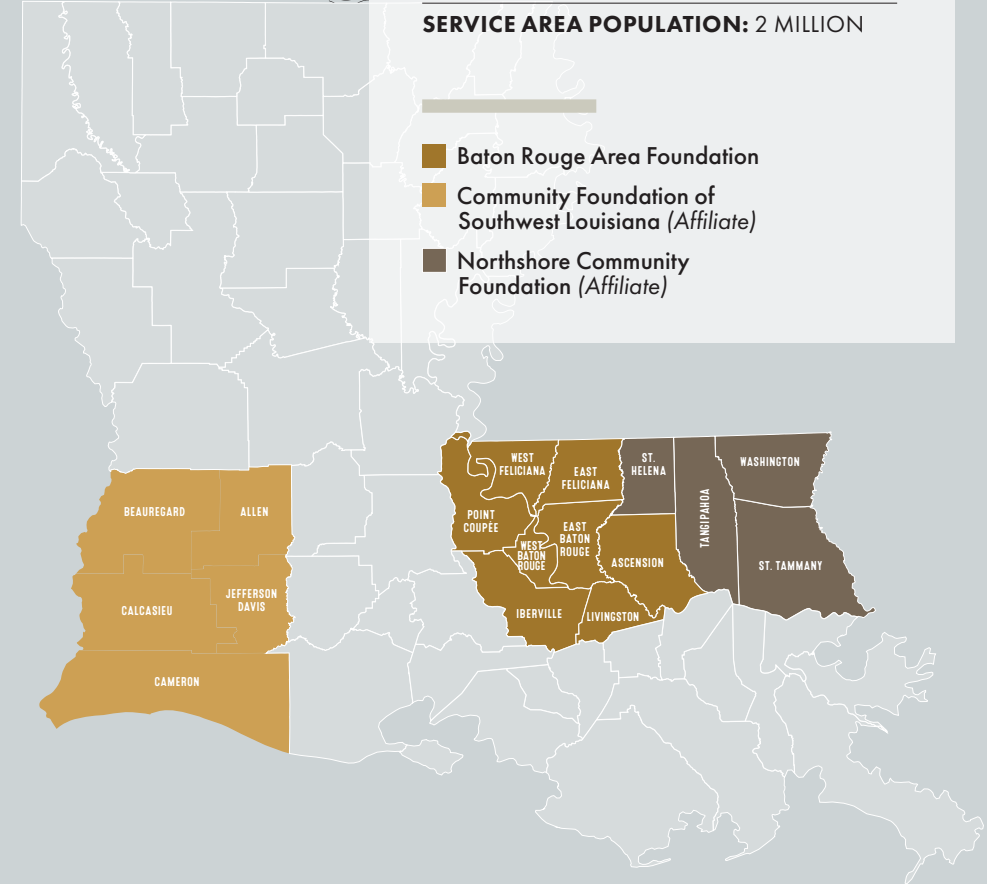

Laurabeth Henderson Hicks lived in Baker. Bill O’Quin resides in Mid City. The two never met, but they are bound by a purpose and a place. Both wanted a better Baton Rouge, where people with mental illness can get the help they need.

In 2013, Bill lost his son, David, who was schizophrenic. Police arrested him for disturbing the peace, and he died in jail 13 days later, terrified and confused. The grieving father was determined that others like his son should get medical care, not confinement. But that was not an option in Baton Rouge at the time.

Laurabeth devoted her career to studying the mind and working in the service of people. She taught educational psychology at Southern University, making nationally recognized contributions to her field. Her students have gone on to teach and counsel people around the country, helping them live happier lives as members of society.

We are grateful that both of them found the Baton Rouge Area Foundation.

Bill told his son’s story to our staff, and the Foundation agreed: jail is no place to send sick people. With support from Bill, we started researching and identified the best solution for Baton Rouge—a treatment center with professionals trained to calm people who are suffering a crisis caused by their mental illness or addictions, or both.

In 2018, on the third try, a tax to pay for the services of the center was approved by a strong majority of voters. Like Bill, they saw the need for compassionate services, not incarceration, for people who have mental illness or are captives of addiction.

In August 2019, Bridge Center for Hope—a nonprofit that began at the Foundation—selected a service provider to operate the crisis stabilization center. Under the management of RI International, a leader in the field, the

center will open in early 2021, with a staff of nurses and therapists caring for up to 5,000 people per year. When people are too confused to be in control of their actions, law enforcement will have a place to take them.



Stories like this interested Laurabeth Hicks. She would read the newspaper in her garden every morning in Baker, her niece tells us, where she followed the work of the Foundation, including the mental health and justice reform projects that we’ve been leading. We learned in December 2019 that Laurabeth had a place in her will for the Foundation, leaving us \$70,000. Like us, she believed that we can change the way people with mental illness are cared for in our parish.

What Bill began in memory of his son, Laurabeth is enabling us to continue with the gift she left. But the work isn’t done; we will do more. Our mental health project was the basis for a pre-trial diversion program that gave some people options, allowing them to choose treatment and recovery over prison. The progress made here paved the way for the next step: a justice reform project that has safely reduced the prison population in EBR, keeping people out of jail who don’t belong there, people like David O’Quin.

We rely on the compassion of our neighbors and the generosity of donors to make our region a better place. We’re fortunate to have the support of more than 1,000 people who give each year, as members and fund donors. They provide us with the goals, the resources and the motivation to find better ways to solve old problems that hold our region back. We are grateful to Bill and Laurabeth, and to the many more like them who share their commitment to this place and the common purpose of making it a better home for everyone who lives here.

CIVIC PROJECTS

THE WATER CAMPUS



IN 2019, THE FOUNDATION AND COMMERCIAL Properties Realty Trust added another research building on The Water Campus and started constructing apartments as well as the main square park. The Water Campus is where scientists and engineers gather to solve one of the most challenging problems of our time: what to do in vulnerable coastal areas threatened by rising seas and vanishing wetlands.

The Water Institute of the Gulf, which is located

on the campus and was begun by the Foundation, provides an example of Louisiana's leadership in coastal science. Last year, Gov. John Bel Edwards named The Water Institute as Louisiana's Innovation and Collaboration Hub, with Institute scientists delivering services like assisting the cities of Houston and Charleston, South Carolina, with plans to withstand more fierce storms. In late 2020, 20 loft apartments and the main square will open on The Water Campus.

CIVIC PROJECTS

GREAT LAKES IN BATON ROUGE

IN 2014, FOUNDATION PRESIDENT and CEO John Davies marked the Foundation’s 50th anniversary by announcing a master plan to save the University/ City Park Lakes, which were growing so shallow that, without help, they would revert to swampland. Five years later, Gov. John Bel Edwards announced that state and local leaders, including Mayor Sharon Weston Broome, LSU and BREC, had committed funding to dredge

the lakes to a depth that would keep them healthy for decades to come, while creating new parks and safe paths. The Foundation has turned the project over to the LSU Real Estate and Facilities Foundation and its partners. It has been delayed as a result of COVID-19; however, partners are continuing planning work so that it can be relaunched in earnest.

CRISIS STABILIZATION CENTER



BILL O'QUIN DIDN'T STOP AT HEARTBREAK. His son, David, whose schizophrenia could sometimes make him violent, died in jail, where too many people with mental illness are taken because first responders have nowhere else to place them. Bill saw clearly that our parish prison cannot double as an asylum, and sick people should be treated, not incarcerated. He sought the Foundation's help. We responded with research into best practices and a thorough plan; voters agreed to a \$6 million annual property tax to put the plan in action. In 2019, the Bridge Center for Hope selected an operator for a crisis stabilization center that will open by early 2021. It will serve up to 5,000 people a year.

JUSTICE REFORM

EAST BATON ROUGE HAS IMPRISONED too many people—about twice as many as comparable parishes and counties. So the Foundation and parish justice officials started a project that safely reduced the prison population by 21% in a little over two years. At the heart of the initiative is a new nonprofit, the Criminal Justice Coordinating Council. It joins criminal justice partners with community advocates to rethink policies

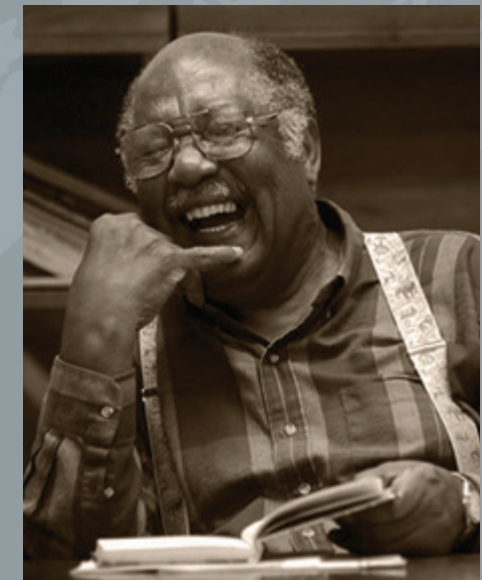
and procedures, such as a streamlined arraignment process that was started in 2019. When the pandemic struck, project collaborators reduced imprisonment by 40%, or more than 600 prisoners. The project was partly funded by a grant from the John D. and Catherine T. MacArthur Foundation as part of the Safety & Justice Challenge and by a financial commitment from the City-Parish.

LEGACY: ERNEST J. GAINES

ERNEST J. GAINES died on Nov. 5, 2019, on the land he worked as a child. Born into a family of tenant farmers on a sugar plantation near False River, he became one of the greatest writers of his generation, earning a nomination for the Nobel Prize in Literature. With Mr. Gaines, the Foundation created the Ernest J. Gaines Award for Literary Excellence, a book prize for African American writers of fiction. Mr. Gaines attended every ceremony, from 2007 to 2019, delivering encouragement to each of the award winners. After each ceremony, he celebrated with his family and friends, and talked warmly, with Gentleman Jack over ice, to guests who loved his stories.

HIGHER EDUCATION

THRIVE ACADEMY’S FIRST graduating class was 18 students in 2019. The school opened a new classroom building in 2019 as well. The Foundation provided financial support and advice to help Sarah Broome found the innovative school in 2011, and it has supported her ever since. Located on Brightside Drive, THRIVE is the only boarding school for vulnerable kids in Louisiana. Today, it enrolls more than 180 students from all parts of the state.

CIVIC PROJECTS

NEIGHBORHOOD, RADICALLY REIMAGINED



We're not going back with the same traditional model of public housing that concentrates poverty in one place. It's key that we create mixed-income residential developments, and that we broaden the work to the surrounding community.”

THE CITY-PARISH GOVERNMENT, through a partnership between East Baton Rouge Parish Housing Authority and Build Baton Rouge, won a \$29.5 million grant to develop the Ardenale neighborhood. The plan, which began as a Foundation project, is to transform 200 acres between North Ardenwood and Lobdell Avenue into a more livable community. The grant will help pay for a YWCA early childhood and woman's center and to replace distressed public housing with mixed-income residential developments, while also threading throughout the neighborhood a network of quality-of-life amenities related to employment, health, and education.

Build Baton Rouge, which is the parish's redevelopment authority, was begun by the Foundation.

CIVIC PROJECTS

BIKESHARE

RESIDENTS ADOPTED AN ALTERNATIVE for commuting. Gotcha began bikeshare service in June 2019 with 50 hubs located in high-demand areas—LSU, Southern University and downtown. Demand for the service exploded in spring, when usage more than tripled during the first months of the pandemic. People pedaled for socially distant exercise and recreation, as well as safe commuting—so much, in fact, that Baton Rouge became the most active city in Gotcha’s network. Bikeshare began as a project of the Foundation.

CIVIC PROJECTS

BATON ROUGE HEALTH DISTRICT

A MASTER PLAN FOR THE Baton Rouge Health District went from recommendations on paper to construction, with new roads opening. Parish government opened an extension of Dijon Avenue—named Constantin Boulevard—to Our Lady of the Lake Children's Hospital. Also in the plan and in the parish's infrastructure budget is Midway, a connector that will run parallel to Essen Lane and Bluebonnet and link to Constantin, ultimately easing

the traffic on the main roads in the Health District. This year, the Health District, a nonprofit started by the Foundation and overseen by leaders of health care providers, became instrumental in pandemic response.

The Health District began with a master plan that was led by the Foundation. We fulfilled a city-parish request for an area plan to FuturEBR, the parish's main guide for growth.

PLANK ROAD REDUX

THE FOUNDATION APPROVED a \$75,000 grant to the East Baton Rouge Redevelopment Authority, now called Build Baton Rouge. The organization combined the money with a \$100,000 grant from Chase and other grants to write a master plan for Plank Road in 2019. The first project from the master plan will be a mixed-use development with a YWCA early childhood learning center, housing and office space for Build Baton Rouge. It will be two blocks from a proposed rapid transit bus station on a CATS line linking North Baton Rouge with downtown and LSU.

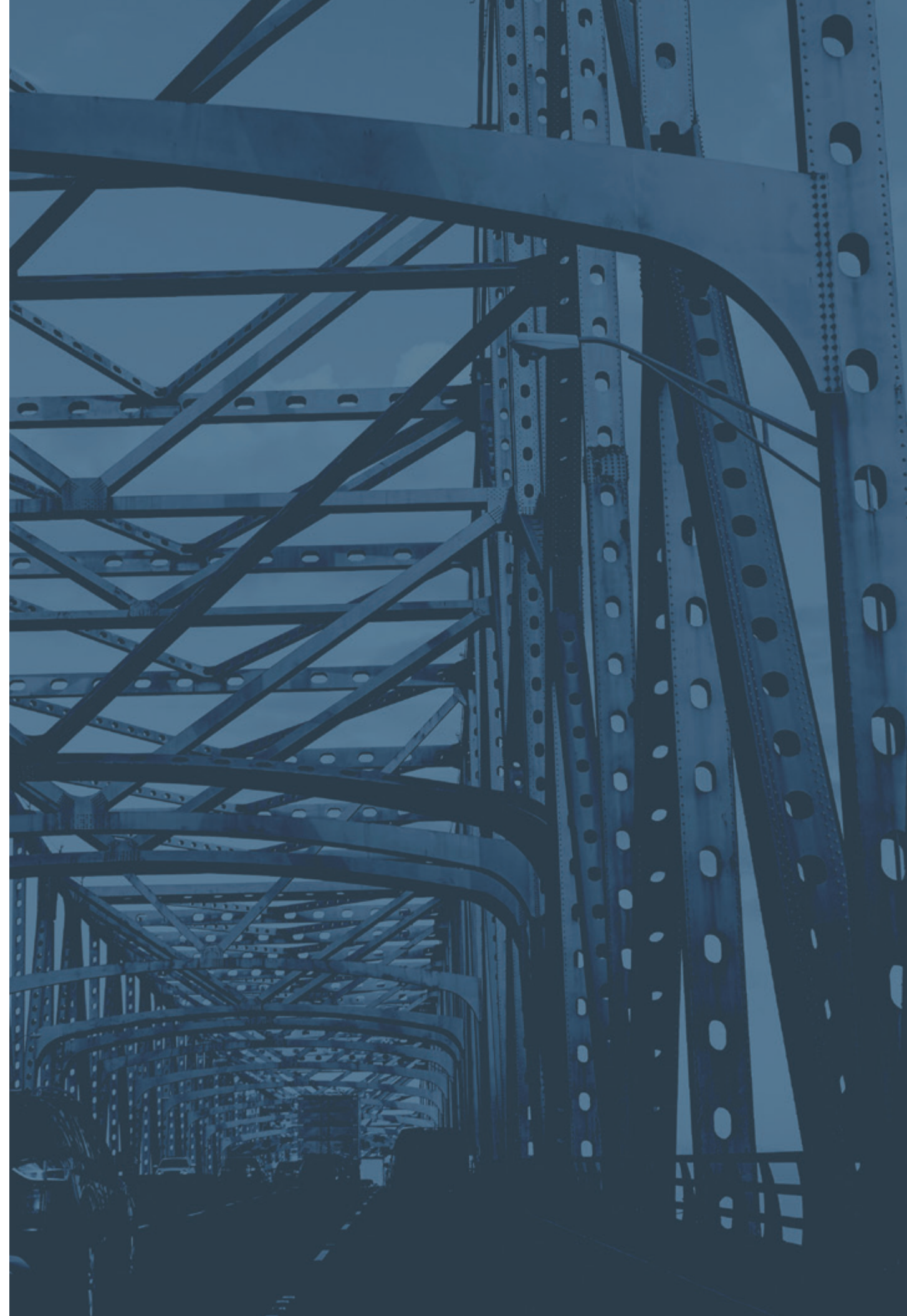
