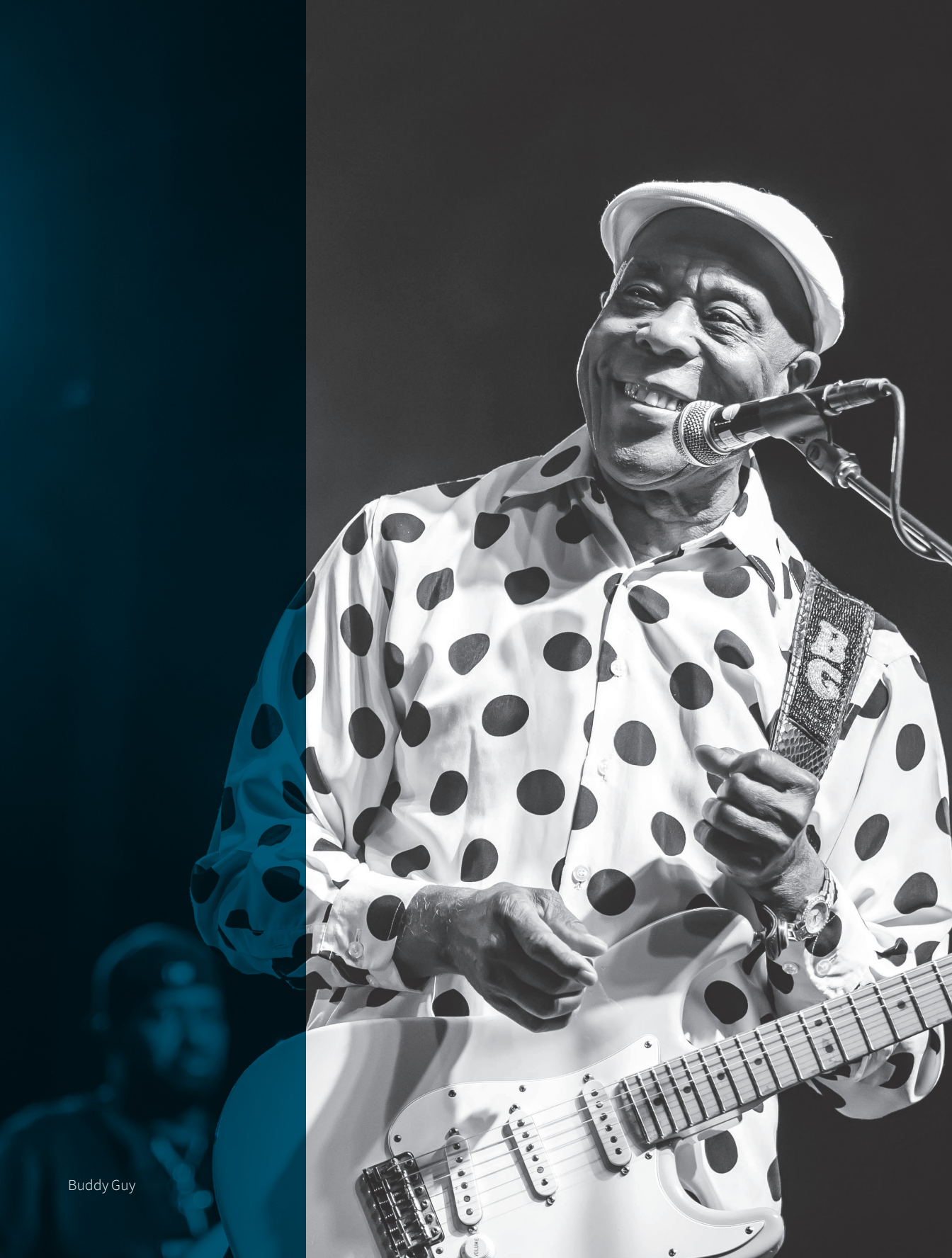

NOTE FROM THE CHAIR



Some years are unforgettable for their momentous events: Katrina and Rita in 2005; the BP oil disaster in 2010; and, last year, the Great Flood, police killing Alton Sterling, and an ambush that killed and injured police. The Sterling killing divided us; the floods brought us together.

We are fortunate at the Foundation in that our vantage point usually lets us see the good in people. And there was much good to see in 2016. After the murders of the police officers, for example, people gave \$1 million to the Foundation's First Responders Fund, demonstrating the care and concern they have for those killed or injured while serving the public. After the floods, more than \$6 million was donated to our flood relief fund from more than 16,000 people around the world, all of them wishing for one thing: that people here could return to their homes and their lives.

Most of us will remember the big events of the last several years—the natural and manmade disasters, the social upheaval. Less conspicuous, maybe, are the improvements our region has been steadily achieving in the midst of it all. For instance, the Foundation has continued working with partners on rebuilding our downtown. We opened the IBM complex there, expanding job opportunities and the quality of life in the heart of our city. We've also begun construction of The Water Campus, which will show the world that Baton Rouge is providing the best water management science to assist the billions of people who, like us, live amid shifting coasts and rising seas.

Inside this annual review, we're taking a quick look back at 2016. You may have noticed that our annual reports have become less detailed. Why? Instead of a comprehensive annual report, we communicate our efforts more often via our quarterly magazine and our bi-weekly digital newsletter. Plus, the efforts of the Foundation are getting regular play in the media.

Still, this annual report serves an important function; the most important one of all. In it, we gratefully recognize by name our fund donors and members—the people who give so that we can carry out projects for civic good and make grants to nonprofits providing direct services to people in need. Herein, we thank you all.

THE WATER CAMPUS

Perhaps the most important project undertaken by the Foundation, the Water Campus started rising on 35 riverfront acres in 2016. This year, the Coastal Protection and Restoration Authority and the LSU Center for River Studies moved onto the campus. Construction on a riverside building for The Water Institute of the Gulf is underway, with occupancy expected in early 2018. The Water Campus is being developed with Commercial Properties Realty Trust, which manages the Foundation's real estate assets. When the Campus is complete, thousands of scientists, engineers and their support staff will offer the best solutions to the worldwide problem of shifting coasts and vanishing wetlands.

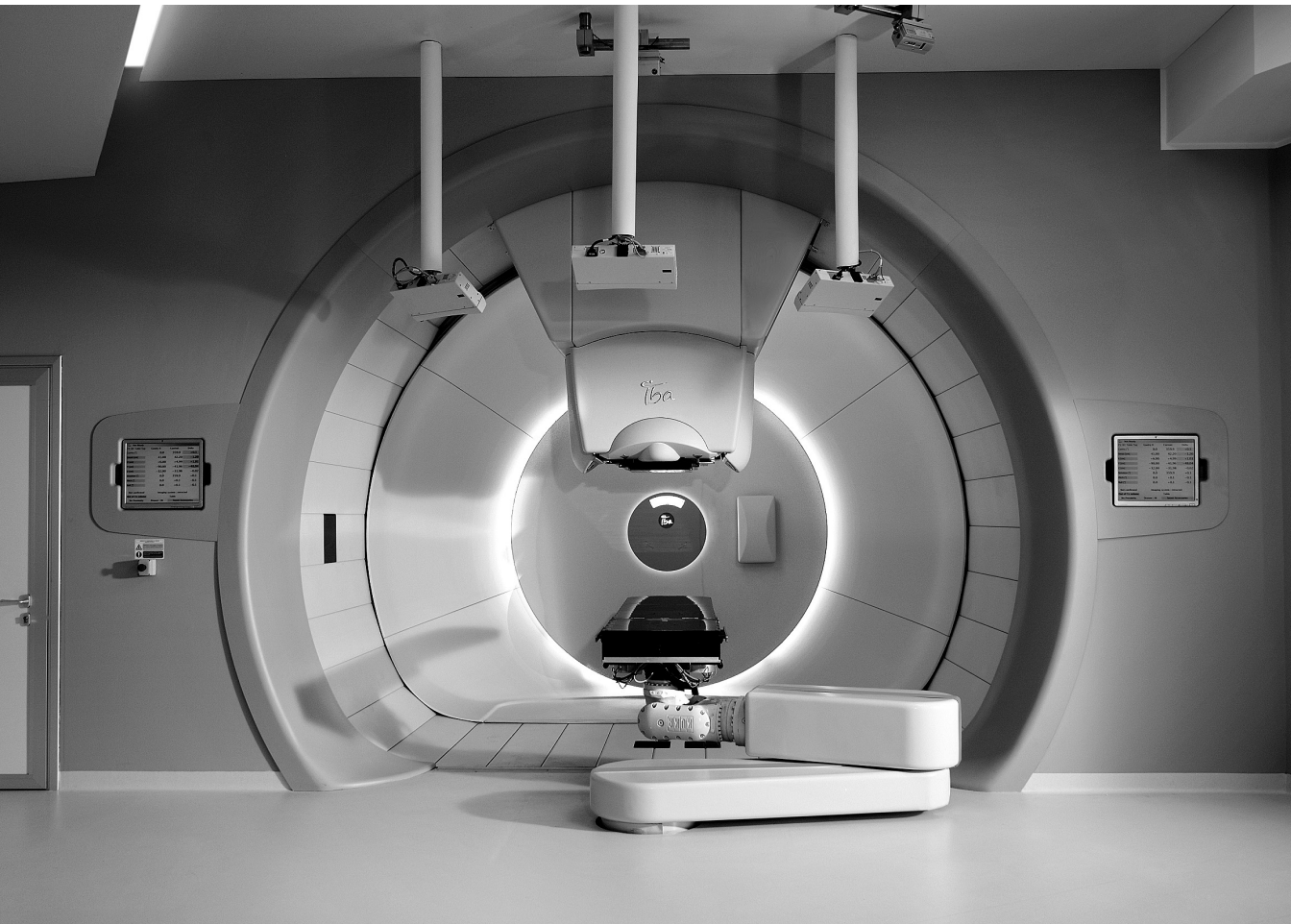

BATON ROUGE HEALTH DISTRICT

The city-parish asked the Foundation to create a master plan for the Health District, a congested area where health care assets are clustered around Essen, Perkins and Bluebonnet. We delivered the plan in 2016 and started a nonprofit to implement it. The nonprofit Baton Rouge Health District has helped to secure a proton cancer treatment facility and is developing a landscape plan for the area, among other things. More than \$450 million in investments are being made in the locale. BRHD is trying to coordinate them for the greatest return.

ARDENDALE

Operated by Baton Rouge Community College, the McKay Automotive Technology Center opened in Ardendale in 2016. Ardendale is a mixed-use community anchored by education institutions. It began as a project of the Foundation and is now under development by the East Baton Rouge Redevelopment Authority. Matt McKay, a former board member and board chair of the Foundation, was the driving force behind creation of the training center, which is named to honor his father, an educator in EBR schools. What's next? A career high school by the EBR Public School System and a second BRCC auto training center—this one for collision repairs—will open at the 200-acre development next year. Retail and housing could be established in the place, spurring development in an area that needs it.

THE NEW MOBILITY

The Foundation's project to offer and advocate for transportation choices, a strategy that has proven to reduce traffic, moved along in 2016. With Commercial Properties Realty Trust, our real estate manager, the city-parish and Entergy Corp., we introduced free electric car charging stations in downtown. The Foundation also supported the introduction of ZipCar. A nonprofit created by the Foundation will start bikeshare in Baton Rouge in 2018, and we devoted considerable resources to advance passenger rail between Baton Rouge and New Orleans, and along the Gulf Coast.

ARTS BLOCK COMPLETED

The Foundation's commitment to build an Arts Block was fulfilled in fall 2016. Onyx Residences, a 28-unit apartment building on the corner of Convention and Third streets in downtown Baton Rouge, was the final project on the block, which is anchored by The Shaw Center for the Arts. In downtown, the Foundation also opened 525 Lafayette, an apartment building, and the IBM building. All were built by our real estate division, Commercial Properties Realty Trust, which takes on projects in challenged areas, such as downtown.

THRIVE ACADEMY

THRIVE Academy opened last year to educate children from underserved communities. It's the only boarding school that is a public charter in Louisiana. Students live five days a week on campus and spend their weekends at home. THRIVE had 110 students when it relocated to its permanent home on Brightside Drive. Founder Sarah Broome will expand the school to 350 middle and high school students. The Foundation's donors have given THRIVE more than \$1 million .

The Foundation's strategic consulting services staff assists nonprofits with strategy and fundraising plans. THRIVE, Companion Animal Alliance, GaitWay Therapeutic Hoersmanship and Sports BR were among our clients in 2016.

In 2016, The Foundation started collaborating with LCTCS and its schools. 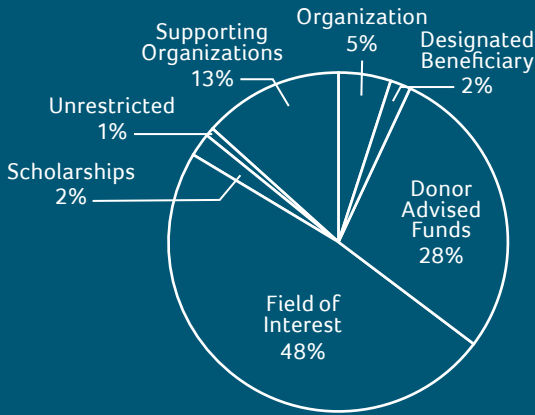

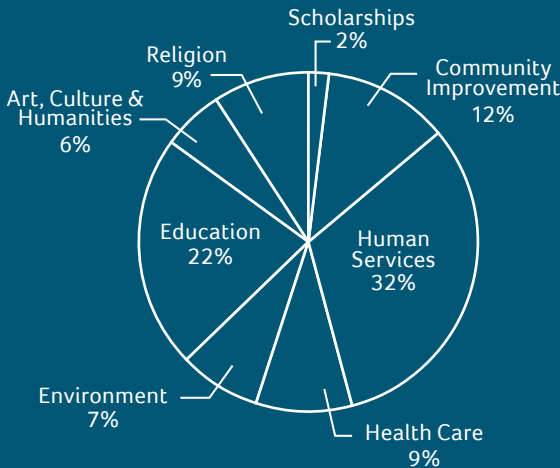
GRANTS BY TYPES OF FUNDS

With our donors, the Foundation has granted more than \$450 million since inception in 1964. Last year, the amount was \$38 million. We categorize grants into seven areas—community improvement, human services, health care, environment, education, religion, scholarships, and arts, culture and recreation.

How do we make the grants? Philanthropists open charitable funds and contribute to them, then they recommend grants to nonprofits from their accounts. As required by the IRS, our board approves the grants and we disburse money to the nonprofits. The Foundation's donor services department advises donors and follows up to make sure the grants are making a difference.

EMPLOYEES 1ST GRANTS

After the Great Flood of 2016, more than 80 companies and institutions opened employee assistance funds at the Foundation through our Employees 1st program. They deposited money in their accounts; the Foundation made grants to their workers, letting them recover and return to work sooner. Donations were tax deductible and the people receiving the grants didn't have to account for the money as ordinary income in their tax filings. We launched online campaigns so that workers and vendors could contribute to the funds as well. We also established a mechanism for making grants, making sure that the need was there and a fair amount was granted to each employee.

LOUISIANA FLOOD RELIEF FUND

At the Foundation, we've learned that it takes time for the federal government to deliver disaster aid. We fill in the gap by using emergency funds at the Foundation and by raising money from other foundations, businesses and people. After the Great Flood of 2016, the Foundation received more than \$6.6 million in contributions to the Louisiana Flood Relief Fund. Of that amount, about \$1.7 million were online donations from around the world. Gov. John Bel Edwards did more than his part, directing corporations and people to donate to the fund.

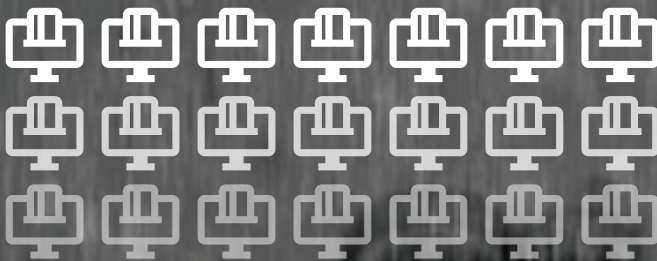
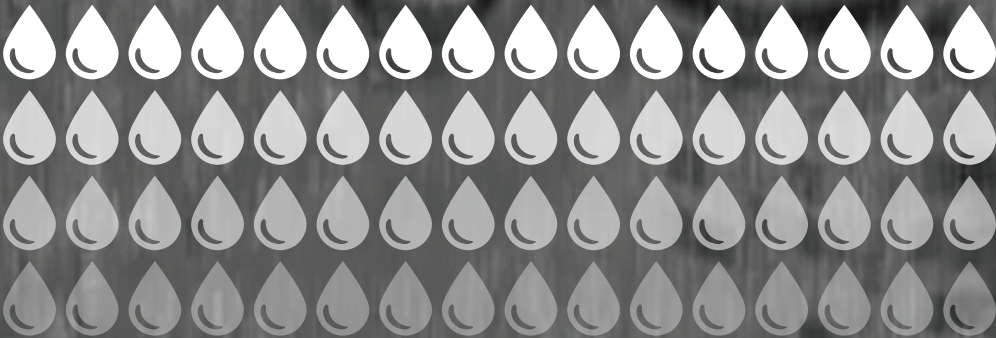

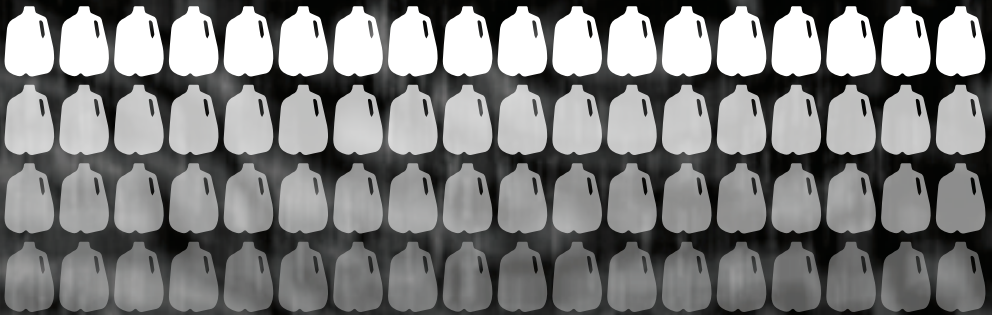

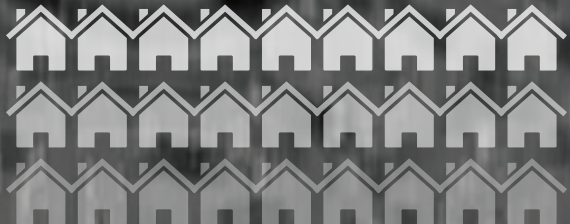

After policemen were killed and injured in Baton Rouge, people from our area and around the country contributed more than \$1.1 million to the First Responders Fund, which made grants to families of slain officers and to the injured ones as well. The fund is overseen by the people who know first responders the best—the leaders of public security and firefighting agencies. In 2017, we started a separate fund for first responders working in surrounding parishes.

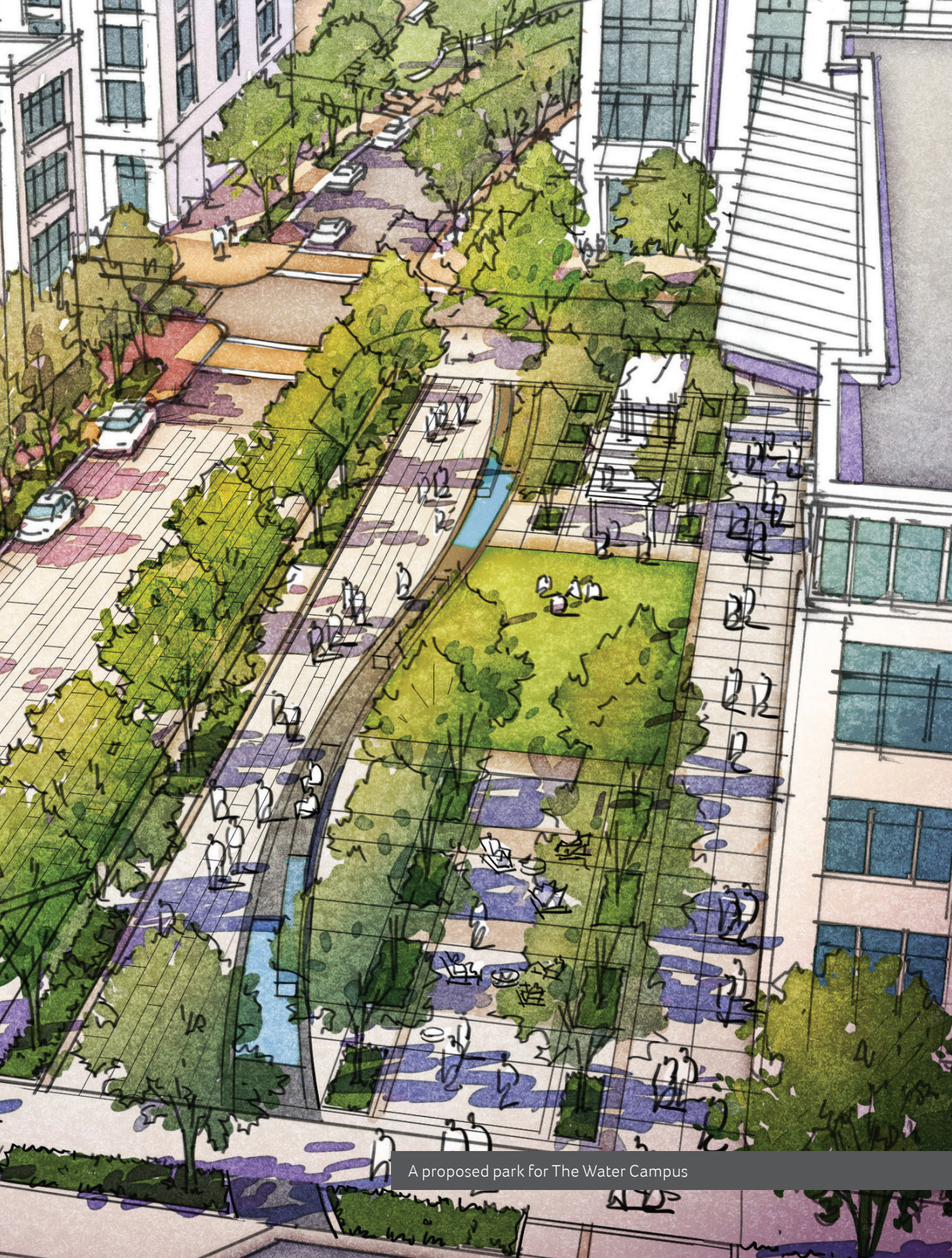
